Electricity: Some booths using electricity will require "pigtaills" to connect. The pigtaills must be returned in good working order at the conclusion of the event or a \$60 fee will be assessed. Access to electricity is very limited and will be assigned at the discretion of the committee. **All vendors must use 12 gage cords.**

To better aid in providing adequate electricity, please list ALL items you will be plugging into an outlet:

Booth Description: List ALL items to be sold, displayed or given away, games to be played and music devices to be used:

*Please note that no tables, chairs, or tents are provided. Street lighting is limited.

**Food Vendors must be set-up by 2:00 p.m. No food vendor may sell any bottled drinks (including water) or canned drinks; only fountain drinks may be sold. All food vendors must complete a Food Establishment Permit Application from Johnson County Community Health Services (JCCHS). A form must be on file with JCCHS. Contact them at 660.747.6121
